
**PLEASE TAKE TIME TO READ THE FOLLOWING IMPORTANT INFORMATION
CONCERNING YOUR TAXES:**

TAX COLLECTION INSTRUCTIONS: If you pay your **REAL ESTATE TAXES** using the installment plan, the due date for the first installment is January 31, 2015. If you pay your **REAL ESTATE TAXES** in full, the due date for the payment is also January 31, 2015. **All PERSONAL PROPERTY TAXES and ALL OTHER SPECIAL CHARGES AND ASSESSMENTS MUST BE PAID IN FULL ON OR BEFORE January 31, 2015.** These payments are to be made to the **TOWN OF FOX LAKE**. The second installment of **REAL ESTATE TAXES** will be payable to Dodge County Treasurer, 127 E. Oak Street, Juneau, WI 53039-1390 on or before July 31, 2015, without interest or penalty; please include a self-addressed stamped envelope if you want a receipt returned.

NOTICE: Please send the correct coupon with each payment. Please do not pay by cash.

The Lottery Credit is included on your bill if notification was received by the Dodge County Treasurer that the home at the address shown was your primary residence as of January 1, 2014. If you feel you are entitled to the Lottery Credit, an application must be completed. The First Dollar Credit is applied to each parcel that contains a real property improvement and the property does not need to be the primary residence of the owner.

Taxes will be collected at the Fox Lake Town Hall at W10543 County Road F on the following dates and times: Friday, December 26, 2014 1:00PM-5:00PM and Saturday, December 27, 2014 9:00AM-3:00PM, and Saturday, January 24, 2015 9:00AM-3:00PM and Saturday, January 31, 2015 9:00AM-3:00PM. You may also pay via mail. Please pay by check or money order payable to the *Town of Fox Lake*. No payments will be accepted at my residence.

DOG LICENSES are required. The license year begins January 1st and ends December 31st. Dog Tax Charges per an amendment to Section 174.05(2) of the Wisconsin Statutes are as follows: \$8.00 for a male or female dog and \$3.00 for a neutered male or a spayed female. You must provide the dog's name, sex, breed, color and proof of rabies vaccination before a license may be issued. A late fee of \$2.00 will be charged for dog licenses not renewed by April 1st.

Boat Launch Fees: The Town of Fox Lake operates boat launches at the three lakes in the Town of Fox Lake; Fox Lake, Lake Emily and Beaver Dam Lake. A launch fee is required at each site. Town property owners may purchase an annual sticker, which is honored at all three launch sites, from the Town Clerk/Treasurer at a cost of \$4.00. The regular charge for users that are not property owners in the Town is \$5.00 for a daily fee and \$40.00 for an annual sticker.

Voting in the Town of Fox Lake: On election days, those persons whose primary residence is in the Town of Fox Lake can vote at the Town Hall, W10543 County Road F, from 7:00AM- 8:00PM. All voters in the Town of Fox Lake must register to vote. The form to be completed to register to vote is GAB-131; this form may be obtained at the Government Accountability Board website www.gab.gov.wi. If anyone wishes to register by mail, this form can be printed, completed and mailed to the Clerk with a copy of your driver's license. If a resident wants to request an absentee ballot this form is also available at the same website. Select form GAB-121, print it, complete it and mail it to the Clerk. If voting by absentee ballot, a registration form GAB-131 must be on file or submitted with the absentee ballot application.

Garbage Pickup & Recycling Information: Please call the Clerk's office at (920)928-3573, (920)763-7910(cell) for questions regarding garbage pickup & recycling information for 2015.

E-Waste: As of September 1, 2010, state law prohibits the disposal of various electronic devices such as: computers, monitors, printers, televisions, VCRs, DVD players and cell phones. The Town of Fox Lake will not accept these items as part of the garbage or recycling service. As of this writing these items may be accepted at American TV & Appliance, Best Buy, Goodwill Industries, Veolia Solid Waste and Aronson Recycling.
