

**OFFICIAL NOTICE
ADVERTISEMENT FOR BIDS**

Notice is hereby given by the Town of Fox Lake of Dodge County, Wisconsin, that it will receive sealed bids for a 1- and/or 5-year solid waste and recycling service contract within the Town of Fox Lake until 1:00PM, local time, on the 11th day of April, 2015, in the office of the Town of Fox Lake Town Hall located at W10543 County Road F of Fox Lake, Wisconsin, 53933. Bids will be publicly opened and read at that time and date.

Bid packets will be provided per request by contacting Town Clerk/Treasurer Mason Zantow and submitting request either by phone (920)763-7910(cell), (920)928-3573(office), by email at townclerk@townoffoxlake.org, or by appointment at the Town of Fox Lake Town Hall at W10543 County Road F, Fox Lake, WI 53933, and will be available April 1, 2015. All sealed bids must be submitted by mail to: Town of Fox Lake, ATTN: Garbage Collection Service Bids, PO Box 124, Fox Lake, WI 53933. All bids must be received no later than the deadline published above.

A general summary of the bid options required for the 1- and/or 5-year solid waste and recycling service contract are as follows (please note that all four [4] options must be addressed in order for submitted bids to be considered):

Option 1 (A): Selective weekly curbside garbage collection for approximately 785-850 residential units using manual pickup including weekly recycling pickup with remainder of collection received at Town Hall at W10543 County Road F, Fox Lake, WI 53933 (weekly collection) including four (4) 12-yard lockable dumpsters and one (1) 30-yard recycling container.

Option 1 (B): Selective weekly curbside garbage collection for approximately 785-850 residential units using carts including weekly recycling pickup with remainder of collection received at Town Hall at W10543 County Road F, Fox Lake, WI 53933 (weekly collection) including four (4) 12-yard lockable dumpsters and one (1) 30-yard recycling container.

Option 2 (A): Universal weekly curbside garbage collection for approximately 1005-1065 residential units using manual pickup including weekly recycling pickup with monthly collection received at Town Hall at W10543 County Road F, Fox Lake, WI 53933 including four (4) 12-yard lockable dumpsters and one (1) 30-yard recycling container.

Option 2 (B): Universal weekly curbside garbage collection for approximately 1005-1065 residential units using carts including weekly recycling pickup with monthly collection received at Town Hall at W10543 County Road F, Fox Lake, WI 53933 including four (4) 12-yard lockable dumpsters and one (1) 30-yard recycling container.
